STEPS TO TAKE FOR ALL NON-EMERGENCY ON-THE-JOB INJURIES

1	The employee immediately reports the injury to a supervisor or human resources department. A comprehensive Employee's Report of Injury Form should be completed as well as an Injury Investigation Report.
2	 The employee should bring the following on his/her visit: A photo ID. Any necessary paperwork the employer may provide, including an executed authorization form for medical treatment. The name and phone number of supervisor or contact person at the company. If applicable, the name and phone number of the company's workers' compensation insurance carrier.
3	The employee should go directly to PromptMed Urgent Care's facility. Employee will notify the PromptMed staff upon arrival that he/she was injured on the job so the claim can be properly filed. The employee will be seen and treated quickly, with compassion.
4	Following the visit, the employer will receive an email or fax from the provider about the employee's injury and any possible work restrictions, as well as information about the employee's follow up appointments and anticipated outcome of injury. Our billing department will contact the employer to get verification and necessary information to process the claim.
